Julie M: Reservations not the perception – not part of the decision-making structure – Clear goals now a NENA governance - just an chat time supported by NENA

Erik H: supports and supports it quarterly, - open environment just a salon

Autumn: wants to have each board member do a 1 minute say hey! At each Bd meeting

Erik H: wants to know what's on the NENA web page and FB and rational (he wants Bd votes and more information on NENA governance on the web page and FB)

Amy: circle back to Matthew for closure; Matthew will put together a one-page concept paper and bring it back to the board

Erik H: feels left out, wants more communication

Autumn: votes and minutes and governance are on the Web page

Ryndi: support Erik – salon topic; what do neighborhood associations do.

Erik H: vote log Erik H: believes he should have been considered for He feels left out. Believes the board seat filling is inconsistent and nor notice, Erik raised several questions/concerns about fairness and consistency on filling Bd seats

Amy: responded and apologized to Erik and tried to explain the process, and that we've been using the same process developed by Carlos on Bd vote on nominations committee recommendations, Bd clarified nominations process at the May Bd meeting, voting has been consistent, Erik has been considered when he has expressed interest, however, Erik has withdrawn himself on one of more such occasions.

Julie M: notes that Erik has not been consistent in his interest to be on the Bd and withdrawn his nomination or consideration one or more times. Explained the nomination and vote process horse race vote -vs- nomination committee recommendation vote

Amy: tries to move meeting on – (Sec. notes, dialogue became unproductive)

Ryndi: responded to Erik and sent him the minutes from past meetings

Julie V: explained the voting process again and that it's been consistent

Erik: still upset, does not agree with Julie M. or Julie V or Amy

John T: interrupted, said something about Pride flags not historic

Amy: moves meeting along

Erik said he felt the appointment process for Board seats has not been fair, straight-forward or transparent

***Board voted to follow the Recruitment Committee process adopted in early 2020-needs to be thoroughly addressed in the new By-Laws at next annual meeting

Discussion that Erik had withdrawn his name from consideration

Amy met with Erik previously and thought his concerns had been addressed We all expressed appreciation for his time with P&Z Committee
